**THE UNIVERSITIES ACT, No. 16 OF 1978**

**Order under Section 25A**

BY virtue of the powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Dr. Bandula Gunawardana, the Minister of Higher Education, Technology and Innovation, having obtained a report under Section 70C of the aforesaid Act, in respect of the National School of Business Management Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PB 4833, do by this Order, amend the Order made under the said Act, and published in *Gazette Extraordinary* No. 2053/40 of January 11, 2018, by the repeal of the Schedule I and II to that Order and Substitution therefor of the following new Schedule I and II as follows :-

“SCHEDULE I

CONDITIONS

National School of Business Management Limited shall, when admitting students for the degree programme relating to the degree specified in Schedule II hereto in respect of the Bachelor of Science Engineering Honours in Computer System Engineering, adhere to the minimum entry qualifications of three (3) simple passes (‘S’) in Physical Science subject stream in one and the same sitting at the GCE (Advance Level) Examination or equivalent.

National School of Business Management Limited shall, when admitting students for the degree programmes relating to the degrees specified in Schedule II hereto in respect of the Bachelor of Science Engineering Honours in Electrical and Electronic Engineering and Bachelor of Science Engineering Honours in Mechatronic Engineering, adhere to the minimum entry qualifications of three (3) simple passes ('S') in Physical Science subject stream in one and the same sitting at the GCE (Advance Level) Examination or equivalent.
