Order under Section 25A

BY virtue of the powers vested in me by Section 25A of the Universities Act, No.16 of 1978,1, Prof. G. L. Peiris, the Minister of Education, having obtained a report under Section 70C of the aforesaid Act, in respect of the International Institute of Health Science (Pvt) Ltd., a company incorporated in Sri Lanka under the Companies Act, No.7 of 2007, bearing Registration Number PV 66370 and located at No.700, Negombo Road, Maththumagala, Ragama, do by this Order and subject to the conditions specified in Schedule I hereto, recognize the International Institute of Health Science (Pvt) Ltd, as a Degree Awarding Institute for the purpose of developing Higher Education therein, leading to the award of the Degree specified in Column I of the Schedule II hereto, of which the abbreviation is set out in the corresponding entry in Column II of the Schedule II hereto.

CONDITIONS

1. International Institute of Health Science (Pvt) Ltd, which has been recognised by this Order as a Degree Awarding Institute may offer the Degree specified in Schedule II hereto, subject to a subject re-review conducted by the Specified Authority every five (5) years from the date of publication of this order.

2. International Institute of Health Science (Pvt) Ltd, shall conduct the degree programme relevant to the Degree specified in Schedule II hereto, only at No.700, Negombo Road, Maththumagala, Ragama.
3. International Institute of Health Science (Pvt) Ltd shall, when admitting students for the degree programme relevant to the Degree specified in Schedule II hereto, adhere to the minimum entry qualification of -
 - (a) three (3) simple passes ('S') in commerce subject stream in one and the same sitting at the GCE (Advanced Level) Examination or equivalent; or
 - (b) three (3) simple passes ('S') in any subject in one and the same sitting at the GCE (Advanced Level) Examination or equivalent with a bridging course approved by the Specified Authority.
