Order under Section 25A

BY virtue of the powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajyantha, the Minister of Education, having obtained a report under Section 70c of the aforesaid Act, in respect of the International College of Business and Technology Limited (ICBT), a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number PB 1437, being recognized as a Degree Awarding Institute, do by this Order and subject to the conditions specified in Schedule I hereto, recognise the branch located at No. 363, D. S. Senanayake Street, Kandy (Kandy branch) of International College of Business and Technology Limited, as a Degree Awarding Institute for the purpose of developing higher education therein, leading to the award of the degrees specified in Column I of the Schedule II hereto, of which the abbreviation is set out in the corresponding entry in Column II of the Schedule II hereto, for the purpose of developing Higher Education therein:-

SCHEDULE I

CONDITIONS

1. International College of Business and Technology Limited (ICBT) – Kandy Branch, shall conduct the degree programmes relevant to the degrees specified in Schedule II hereto, only at No. 363, D. S. Senanayake Street, Kandy, Sri Lanka.
2. International College of Business and Technology Limited (ICBT) – Kandy Branch, is recognised to offer the degrees specified in Schedule II hereto, Subject to the five (5) year re-review conducted by the Specified Authority.

- (a) three (3) ‘simple passes’ (S) in Commerce subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent; or
- (b) three (3) ‘simple passes’ (S) in any subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent with a bridging course approved by the Specified Authority.
4. International College of Business and Technology Limited (ICBT) – Kandy Branch, shall, when admitting students for the degree programme relevant to the degree specified in Schedule II hereto in respect of the Bachelor of Science Honours in Software Engineering, complete with a minimum of 120 credits (SLQF Level 6), adhere to the minimum entry qualifications of –
- (a) three (3) ‘simple passes’ (S) in Physical Science subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent; or
- (b) three (3) ‘simple passes’ (S) in any subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent with a bridging course approved by the Specified Authority.
