Order under Section 27(1) (b) read with Section 25A

BY virtue of the powers vested in me by Section 27(1) (b) read with Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education, having obtained a report under Section 70C of the aforesaid Act, in respect of the Colombo International Nautical and Engineering College (Private) Limited (CINEC), a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PV 17745, being recognised as a Degree Awarding Institute, do by this Order, amend the Schedule I to the Order made under the said Act, and published in *Gazette Extraordinary* No. 2067/15 of April 19, 2018, by the repeal of condition (b) in Schedule I and the substitution thereof of the following :-

“(b) Bachelor of Education Honours in Biological Sciences, adhere to the minimum entry qualification of three (3) simple (S) passes from among the subjects Biology, Chemistry, Physics, and Agriculture in one and the same sitting at the GCE (Advanced Level) examination conducted by the Department of Examinations of Sri Lanka or equivalent:

Provided however, in addition to the above mentioned minimum entry qualifications, a student may be admitted to follow the Degree Programme leading to the Degree of Bachelor of Education Honours in Biological Sciences, if such student has successfully completed -

- any one of the qualifying lateral entry programmes; and
- all modules as required to fill any gap to gain the approved credits, prior to the sixth semester of the Degree Programme,

BY virtue of the powers vested in me by Section 27(1) (b) read with Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education, having obtained a report under Section 70C of the aforesaid Act, in respect of the Colombo International Nautical and Engineering College (Private) Limited (CINEC), a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PV 17745, being recognised as a Degree Awarding Institute, do by this Order, amend the Schedule I to the Order made under the said Act, and published in *Gazette* Extraordinary No. 2053/39 of January 11, 2018, by the repeal of conditions (b) and (c) in Schedule I and the substitution therefor of the following :-

“(b) Bachelor of Education Honours in English, adhere to the minimum entry qualification of three (3) simple (S) passes if any subject Stream including English as a main subject in one and the same sitting at the GCE (Advanced Level) examination conducted by the Department of Examinations of Sri Lanka or equivalent:

Provided however, in addition to the above mentioned minimum entry qualifications, a student may be admitted to follow the Degree Programme leading to the Degree of Bachelor of Education Honours in English, if such student has successfully completed -

- (a) any one of the qualifying lateral entry programmes; and
 - (b) all modules as required to fill any gap to gain the approved credits, prior to the sixth semester of the Degree Programme,

Provided however, in addition to the above mentioned minimum entry qualification, a student may be admitted to follow the Degree Programme leading to the Degree of Bachelor of Education Honours in Physical Sciences Degree Programme, if such student has successfully completed-

- (a) any one of the qualifying lateral entry programmes; and
(b) all modules as required to fill any gap to gain the approved credits, prior to the sixth semester of the Degree Programme,

BY virtue of the powers vested in me by Section 27(1) (b) read with Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education, having obtained a report under Section 70C of the aforesaid Act, in respect of the National School of Business Management Limited (NSBM), a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registraion number PB 4833. being recognized as a Degree Awarding Institute, do by this Order, amend the Schedule II to the Order made under the said Act, and Published in *Gazette* Extraordinary, No. 2302/17 of October 19. 2022, by the addition immediately after the entry “Bachelor of Management Honours in Applied Economics” appearing in Column I and its corresponding entry in Column II thereof, of the entries specified under Column I and Column II respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto.

SCHEDULE I

CONDITIONS

1. National School of Business Management Limited Shall, when admitting students for the degree programme specified in Schedule II hereto in respect of the Bachelor of Laws Honours, complete with a minimum of 120 credits (SLQF Level 6), adhere to the minimum entry qualification of -
 - (a) three (3) ‘credit passes’ (C) in any subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent; and
 - (b) six (6) passes with three (3) ‘credit passes’ (C) including credit passes for English and Sinhala or Tamil, in one and the same sitting at the GCE (Ordinary Level) Examination conducted by the Department of Examinations of Sri Lanka or an examination recognized by the Department of Examinations of Sri Lanka as equivalent.
2. National School of Business Management Limited is recognized to offer the degree specified in Schedule II hereto, subject to the five (5) year re-review conducted by the specified Authority.
