### Government Notifications

UNIVERSITIES ACT, No. 16 OF 1978

Order under Section 27(1)(b) read with Section 25A

BY virtue of powers vested in me by Section 27(1)(b) read with Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education having obtained a report under Section 70C of the aforesaid Act, in respect of the International College of Business and Technology Limited, a company incorporated in Sri Lanka under the Companies Act. No. No.7 of 2007 and bearing Registration Number PB 1437 and located at No.36, De Krester Place, R. A. De Mel Mawatha, Colombo 04, being recognized as a degree awarding institute, do by this Order amend the Schedule II to the Order made under the said Act, and published in *Gazette Extraordinary* No. 2302/17 of October 10, 2022, by the addition immediately after the entry “Bachelor of Science Honours in Software Engineering” appearing in *Column I* and it’s corresponding entry in *Column II* thereto, of the entries specified under *Columns I and II* respectively of the Schedule II hereto, subject to the conditions specified in schedule I hereto :-

#### SCHEDULE I

#### CONDITIONS

1. International College of Business and Technology Limited shall, when admitting students for the degree programme specified in Schedule II hereto in respect of the Bachelor of Science Honours in Information Technology in Cyber Security, Bachelor of Science Honours in Information Technology in Data Science and Bachelor of Science Honours in Information Technology in Artificial Intelligence with a minimum of 120 credits (SLQF Level 06), adhere to the minimum entry qualification of -

- (a) At least three (03) simple passes (S) in Physical Science subject stream or Engineering Technology stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification ; or
- (b) At least three (03) simple passes (S) in any stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification and a simple pass (S) for Information & Communication Technology, in any attempt at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification and a Credit pass (C) in Mathematics at the GCE Ordinary Level Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification ; or
- (c) At least three (03) simple passes (S) in any stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification and a Credit pass (C) in Mathematics at the GCE Ordinary Level Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification with a bridging programme approved by Specified Authority.
2. International College of Business and Technology Limited shall be recognized to offer degrees specified in Schedule II hereto subject to the five (05) years re-review conducted by the Specified Authority.
